## **Conditions for reproduction of Scurlock Studio photographs**

1. The Smithsonian Institution owns copyrights held by the Scurlock Photographic Studio. The Archives Center, National Museum of American History, Smithsonian Institution grants permission for reproduction of these photographs only to the extent of our ownership of the rights relating to each image. Certain images may be protected by copyright, trademark, or related interests not owned by the Institution. The responsibility for ascertaining whether such rights exist and for obtaining all other necessary permissions remains with the applicant/user.
2. The user understands and agrees that he/she has the sole responsibility for acquiring any and all permissions as may be necessary from the subject or subjects whose images appear in the Scurlock photographs. The user agrees to indemnify and hold harmless the Smithsonian Institution for all claims, damages, actions, judgments, and expenses (including reasonable attorneys' fees) based on allegations of invasion of privacy and/or rights to publicity arising from the user's failure to obtain adequate permissions from the subjects in the photographs.
3. The user agrees to use the material for appropriate and legal purposes.
4. The user agrees to the following credit line: Scurlock Photographic Studio Records, Archives Center, National Museum of American History. The user also agrees to comply with any further written instructions regarding credit line or use of the name of the Smithsonian Institution, National Museum of American History, or Archives Center.
5. Fees are for one-time, non-exclusive, world rights, in one language only. The user must apply to the Archives Center to use the materials in any other project. Applicants may request a waiver or fee reduction for reproduction in a non-profit or scholarly publication with an educational or cultural mission, a limited audience, and a press run of less than 8,000 copies, or for use in a museum exhibition or workshop.
6. The user agrees to supply the Archives Center with one copy of the completed project and to notify the Archives Center of initial broadcast, public screening, or publication dates of the described project.
